  - Company Outing;
  - Year-End General Assembly;
  - Fortuitous Event;
  - All other occasions where the branches are closed or will have an early closing.
- Discount on penalty only will be given to customers who are close contacts or COVID-19 patients who undergone quarantine. Certificate from LGU stating that they are quarantined on a certain period must be presented.
- 3. Special discount must be approved by the management regardless of the amount and shall be documented thru SRF for the meantime in order not to disrupt the operations.
- 4. Once approved, the One-Time Password (OTP) shall be forwarded to the requesting branch by the assigned Area Supervisor. Assistant Manager will forward the OTP in the absence of Area Supervisor. Approval code will be sent to:
  - Assigned Area Supervisor;
  - Assistant Manager for Branch Operations;
  - Assistant Manager for Central Support Services;
  - Chief Operations Officer c/o IT Department
